In 2024, the Organization developed two versions of a new national traveling exhibition about the WWII Incarceration of Japanese Americans and other historic and modern-day events that parallel aspects of this history to encourage visitors to stand up for the rights of all Americans. The organization debuted the free-standing version at the annual conference of the National Council for the Social Studies, the "largest professional association in the country devoted solely to social studies education." As part of its ongoing education work, the Organization released new lesson plans and continued to distribute its education toolkit to teachers free of charge, which includes a variety of resources for teachers to use with students in grades 3 and above. In addition, representatives from the Organization addressed audiences of all ages at a range of events across the country, from educator conference presentations and workshops to employee talks and public events.
